1. Acknowledge that arising from the presence of wild and dangerous animals, reptiles, birds and insects present in and associated with game reserves and/or game lodges, I appreciate that there is a real danger and risk of suffering bodily harm, injury, death while present on Amakhala Game Reserve.
2. Acknowledge and declare that I enter Amakhala Game Reserve fully aware of the danger and risk inherent in the presence of wild and dangerous animals, reptiles, birds and insects.
3. On behalf of myself, my spouse, my common law wife/husband, my children, whether minor or adult, any dependants or relatives and/or any persons accompanying me to Amakhala Reserve, waive and abandon all claims of whatsoever cause or nature and howsoever arising against Amakhala Game Reserve, their associates, servants, employees, directors, shareholders and/or any other person connected, whether directly or indirectly with that operation of Amakhala Game Reserve, and any facilities accommodated on the properties belonging to Amakhala Game Reserve. The waiver and abandonment relates to any claim arising out of harm, injury, death or loss suffered whilst entering or exiting the premises or property of Amakhala Reserve and whether arising from an act or commission or omission on the part of those hereby indemnified.
4. Indemnify and hold harmless Amakhala Game Reserve, its associates, servants, employees and/or other person connected, whether directly or indirectly with the operation and running of Amakhala Game Reserve and fellow guests and invitees from any and all claims of whatsoever nature which may arise on behalf of myself, my spouse, common law wife/husband, my children, whether minor or adult, any dependants or relatives and/or any person accompanying me to Amakhala Game Reserve, whether as my invitee or otherwise, who may suffer injury or loss whilst entering or exiting the premises or property of Amakhala Game Reserve and whether arising from any act or commission or omission on the part of those hereby indemnified.
5. Declared and warrant that I am authorised to make and give the foregoing waiver of claims and indemnity.
6. Acknowledge that any emergency medical treatment arranged or paid for by the Amakhala Reserve shall be at the discretion of the owners of Amakhala Game Reserve and without prejudice to their rights and without any admission of liability on their part.
7. Acknowledge that I have read and understand the foregoing acknowledgement, waiver and indemnity and that I fully understand the meaning and effect thereof and that I am bound thereby without limiting time.
